In case of staying in other than Guest House/Hostel, proper rent agreement copy along with rent receipt and electronic transfer of rental payment have to be submitted along with the PAN Number of the owner for consideration of reimbursement. Transaction of bills related to boarding, lodging and incidental which are made through Electronic Mode will only be considered for reimbursement.
- 7. A short report (2-3 typed pages) should be sent to the Academy immediately after completion of the visit along with a certificate of completion from the Host Institute.
